**C.**  **Request for a Waiver** from one or more of the Rules and Regulations, Deed Restrictions or Bylaws of Texas National Property Owners' Association, Inc. Forms available at P.O.A. and **thetexasnational.com**.

### I hereby agree to the following General Requirements:

1. No work shall begin until plans have been approved. All work must be in compliance with the Laws of Texas, Montgomery County, Codes, Standards and Manufacture's Recommendations.

2. The construction site must be kept clean and orderly. The street must kept clean of dirt & debris and measures taken to prevent damage to street, curbs and other property.

3. If concrete pour is involved, sludge shall not be deposited on streets, rights-of-way or private property under penalty of a \$1000 fine.

4. Work must begin within 60 days of approval and must be completed within 1 year.

I hereby authorize the DRC Committee and/or it's agents to, at all times during and upon completion of the work, have access to my property to inspect the work.
